WHEREAS, pursuant to Section 76 of RA. 9184 states that, "any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "saw no need to seek authority from the City Council prior to entering into a contract";

WHEREAS, however, to further enhance transparency and accountability the Hon. City Mayor Atty. Jaime R. Fresnedi submitted to the Sangguniang Panlungsod the Construction Agreement;

WHEREAS, two (2) bidders were submitted on August 9, 2016 and bid passed the preliminary examination of bid;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, FRAMECON BUILDERS its bid has been found responsive to Approved Budget for the Contract (ABC);

WHEREAS, the amount appropriated for the said project shall be taken from the 2016 Executive Budget;

WHEREAS, the Approved Budget for the Contract (ABC) for the project construction of loading bay and retaining wall is Two Million Twenty Eight Thousand Five Hundred Eighteen Pesos and 34/100 (Php2,028,518.34);



NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 8<sup>th</sup> Sangguniang Panlungsod, to authorize the City Mayor Hon. Atty. Jaime R. Fresnedi, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with Framecon Builders for the project Road Upgrading and Drainage Rehabilitation located at Sampaguita Street, Lodora Village, Barangay Tunasan, Muntinlupa City in the amount of Two Million Twenty Six Thousand Five Hundred Eighteen Pesos and 34/100 (Php2,026,518.34) which amount shall be taken from the 2016 Executive Budget.
