ANGELES ENTERPRISES FOR THE PROJECT ROAD REBLOCKING LOCATED AT DON JESUS BOULEVARD, ALABANG HILLS VILLAGE, BARANGAY CUPANG, MUNTINLUPA CITY IN THE AMOUNT OF FOUR MILLION THREE EIGHTY EIGHT THOUSAND ONE HUNDRED (PHP4,388,100.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2016 EXECUTIVE BUDGET.

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "saw no need to seek authority from the City Council prior to entering into a contract";

WHEREAS, however, to further enhance transparency and accountability the Hon. City Mayor Atty. Jaime R. Fresnedi submitted to the Sangguniang Panlungsod the Construction Agreement;



**WHEREAS**, two (2) bidders was submitted on August 30, 2016 and bid passed the preliminary examination of bid;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, E.M. Angeles Enterprises its bid has been found responsive to Approved Budget for the Contract (ABC);

**WHEREAS**, the amount appropriated for the said project shall be taken from the 2016 Executive Budget;

WHEREAS, the Approved Budget for the Contract (ABC) for the project Road Reblockig is Four Million Three Hundred Ninety One Thousand, One Hundred Sixty Two Pesos and 98/100 (Php4,391,162.98):

WHEREAS, the project was awarded to E.M. Angeles Enterprises who being the lowest bidder for the project, Road Reblocking located at Don Jesus Boulevard, Alabang Hills Village, Barangay Cupang, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 8<sup>TH</sup> Sangguniang Panlungsod, to authorize the *City Mayor Hon. Atty. Jaime R. Fresnedi,* in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with E.M. Angeles Enterprises for the project *Road Reblocking* located at Don Jesus Boulevard, Alabang Hills Village, Barangay Cupang, Muntinlupa City in the amount of *Four Million Three Hundred Eighty Eight Thousand One Hundred Pesos (Php4,388,100.00)* which amount shall be taken from the *2016 Executive Budget*.
