WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, **“the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances”**;

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, **“xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned”**;

WHEREAS, the Saklolo at Gabay ng Ina at Pamilya, Inc., (SAGIP) is a non-governmental organization duly registered with the **Securities and Exchange Commission (SEC)** under Registration No. A1999-12314 and accredited by the Sangguniang Panlungsod by virtue of Resolution No. 16-004;

WHEREAS, the City Government of Muntinlupa shall continue to provide financial assistance to the organization for the implementation of their projects, **subject to availability of funds**, and the funds shall be charged against the Miscellaneous, Operating and Other Expenditures (MOOE) of the **Gender and Development Office (GAD)**.

- a. **Name of Project:** Operation of the SAGIP Center
- b. **Intended beneficiaries:** Women and Children who are victims of physical, sexual, or psychological abuse, of whatever field (domestic, commercial and industrial).
- c. **Services to be delivered:** Crisis Intervention (24-hour hotlines, Emergency Shelter, Medical Assistance); Legal Services, Referral Services (to other national or local agencies, programs or services); Psychological Services, and Community and School-Based Advocacy Programs.
- d. **Project Cost Estimate:** The City Government of Muntinlupa will give Financial Assistance of One Million Five Hundred Thousand Pesos (Php1,500,000.00) to SAGIP's annual operational cost.
- e. **Brief Project Description:** The SAGIP Center was intended as a crisis center for abused women and children and created as one –stop facility wherein abuse cases could be processed with minimum trauma on the part of the victim, providing short-term shelter to those in need of emergency housing.
- f. **Site and Location:** Sagip Center, Civic Drive, Filinvest Corporation City, Barangay Alabang, Muntinlupa City.

WHEREAS, the **Memorandum of Agreement (MOA)** shall have force and effect immediately upon the execution hereof, and shall be subject to periodic evaluation, and review by the City, through the Social Services Department (SSD) which shall recommend any modification, amendment, or revocation of the terms thereof, when deemed necessary, or when declared unlawful by future statute or ordinance;

WHEREAS, **Memorandum of Agreement (MOA)** shall initially be effective until December 31, 2016;

WHEREAS, the City Legal Office reviewed the **Memorandum of Agreement (MOA)** and rendered an opinion that nothing in its provisions legally objectionable hence the MOA was submitted to the City Council and favorably endorsed the grant of authority to the Hon. City Mayor Atty. Jaime R. Fresnedi;
