WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances":

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned':

WHEREAS, the Securities and Exchange Commission (SEC) is an administrative agency of the Government of the Republic of the Philippines duly organized and existing under and by virtue of the laws of the Republic Act of the Philippines;

WHEREAS, Article 8 of the Rules and Regulations Implementing the Local Government Code of 1991 mandates that "every province, city and municipality shall endeavor to establish a government center where offices, agencies or branches of National Government, LGUS, or GOCCs may, as far as practicable, be located;

WHEREAS, the City Government of Muntinlupa is a business friendly city with a prime objective to be an investment hub in the South, readily accessible to the neighboring cities namely, Las Piñas, Taguig, Parañaque and provinces of Cavite Laguna, Batangas Rizal and Quezon;

WHEREAS, the Local Government Unit is mandated by law to address the needs of its constituents, empower its people and allow them the widest possible participation in governance;

WHEREAS, the City Government intends to address poverty through the implementation of programs, whether locally generated or in coordination and partnership with related Government Agencies;

WHEREAS, Local Government of Muntinlupa has agreed to cooperate and provide necessary support and providing the SEC Satellite Office for purpose of bringing its services closer not only to the people of Muntinlupa but also those within the CALABARZONE area:

WHEREAS, there is a need to authorized the Local Chief Executive to enter into Memorandum of Agreement (MOA) with Securities and Exchange Commission (SEC) for strengthened partnership and collaboration to attain successful, effective and efficient implementation of this social protection efforts;

WHEREAS, the Memorandum of Agreement (MOA) with the Securities and Exchange Commission (SEC) covers the following, among others:

1. Use the premises exclusively for the operation of the satellite office

2. Shoulder cost of internet charges

3. Keep the premises in clean, safe and sanitary condition at all times

4. Ensure that the satellite office within the city premises shall be ready for operations in accordance with the timetable agreed upon by the parties:

5. Ensure that the satellite office is manned by properly-trained and qualified SEC employees/personnel from 8:00 o'clock in the morning to 5:00 o'clock in the afternoon, Mondays to Fridays, excluding legal holidays and special non-working days, and that it will be able to provide its services to the public as represented;

6. Provide necessary documents and supplementary materials for information and promotional purposes; and

7. Conduct necessary training and/or seminars to Local Government of Muntinlupa personnel to equip them in providing information on handling registration corporate and partnership processes to the transacting public.

8. The parties agree to execute such other agreements, issue implementing guidelines, procedures, amendments or modification as may be required by the circumstances in order to insure the effective implementation of SEC Registration processes in the City Government of Muntinlupa.

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by 8th Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor Atty. Jaime R. Fresnedi to enter into a Memorandum of Agreement (MOA) with the Securities And Exchange Commission (SEC) in providing the SEC Satellitè Office in the City of Muntinlupa.
