A RESOLUTION AMENDING THROUGH THE DELETION OF THE TENTH (10TH) WHEREAS CLAUSE OF RESOLUTION NO. 15-289, ENTITLED, "A RESOLUTION ENDORSING TO THE INFORMATION TECHNOLOGY-PHILIPPINE ECONOMIC ZONE AUTHORITY (IT-PEZA) THE APPLICATION OF SOUTHKEY DEVELOPMENT CORPORATION FOR THE DECLARATION OF 10 STOREY SOUTHKEY BUILDING AS INFORMATION TECHNOLOGY CENTER (IT CENTER) TO BE KNOWN AS "SOUTHKEY BUILDING" LOCATED AT INDO-CHINA DRIVE, FILINVEST NORTHGATE BUSINESS DISTRICT, BARANGAY ALABANG, MUNTINLUPA CITY" THUS IN EFFECT FAVORABLY ENDORSING TO THE PEZA THE WHOLE SOUTHKEY BUILDING AS INFORMATION TECHNOLOGY CENTER.

WHEREAS, on 27th day of November, 2015, the 7th Sangguniang Panlungsod of Muntinlupa passed Resolution No. 15-289 where it is stated that the application of Southkey for PEZA endorsement is only for its 4th to 10th floor";

WHEREAS, on December 9, 2015, Mr. Jose Ma. G. Montinola, president of Southkey Development Corporation, wrote a letter clarifying that the 484.23 square meters commercial areas ground floor space is also intended to be included as an IT dedicated area;

WHEREAS, as the inclusion of its commercial area is key to it being recognized by the PEZA as business locator and hence will contribute not only to the economy in the city but also to the country as well;

WHEREAS, there is a need to amend Resolution No. 15-289, by deletion the 10th WHEREAS Clause, which provides that, "the Southkey Development Corporation has applying as PEZA registered the 4th Floor to 10th Floor of the Southkey Building";
