

A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH KME DESIGN AND CONSTRUCTION FOR THE PROJECT CONSTRUCTION OF ADDITIONAL 2ND FLOOR FOR OUTPATIENT DEPARTMENT LOCATED AT OSPITAL NG MUNTINLUPA (OSMUN), BARANGAY ALABANG, MUNTINLUPA CITY IN THE AMOUNT OF FIVE MILLION FIVE HUNDRED SIXTY FIVE THOUSAND SEVEN HUNDRED TWENTY SIX PESOS AND 50/100 (PHP5,565,726.50) WHICH AMOUNT SHALL BE TAKEN FROM THE 2016 EXECUTIVE BUDGET.

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others";

WHEREAS, pursuant to Section 76 of RA. 9184 states that, "any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "saw no need to seek authority from the City Council prior to entering into a contract";

WHEREAS, however, to further enhance transparency accountability the Hon. City Mayor Atty. Jaime R. Fresnedi submitted to the Sangguniang Panlungsod the Construction Agreement,

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the project additional 2nd Floor for Outpatient Department located at Ospital ng Muntinlupa (OSMUN), Barangay Alabang, Muntinlupa City in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, one (1) contractor/bidder submitted letter of intent and application for eligibility, and was found eligible on December 11, 2015;

WHEREAS, lone bidder was submitted on December 11, 2015 and bid passed the preliminary examination of bid;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, KME Design And Construction its bid proposal has been found to be responsive;

WHEREAS, the amount appropriated for the said project shall be taken from the 2016 Executive Budget;

WHEREAS, the Approved Budget for the Contract (ABC) for the project construction of additional 2nd Floor for Outpatient Department is Five Million Five Hundred Seventy One Thousand Seven Hundred Thirty Seven Pesos and 62/100 (Php5,571,737.62);


WHEREAS, the project was awarded to KME Design And Construction who being the responsive bidder for the project, additional 2nd Floor for Outpatient Department located at Ospital ng Muntinlupa (OSMUN) Barangay Alabang, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 7<sup>TH</sup> Sangguniang Panlungsod, to authorize the City Mayor Hon. Atty. Jaime R. Fresnedi, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with KME Design And Construction for the project construction of additional 2<sup>nd</sup> floor for outpatient department located at Ospital ng Muntinlupa (OSMUN), Barangay Alabang, Muntinlupa City in the amount of Five Million Five Hundred Sixty Five Thousand Seven Hundred Twenty Six Pesos and 50/100 (Php5,565,726.50) which amount shall be taken from the 2016 Executive Budget.


