A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH VIC VERA BUILDERS, INC., FOR THE PROJECT CONSTRUCTION OF CONSTRUCTION OF DRAINAGE SYSTEM LOCATED AT STO. NIÑO AVENUE, PHASE 4, STO. NIÑO VILLAGE, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF TWO MILLION NINE HUNDRE FORTY NINE THOUSAND TWO HUNDRED FORTY EIGHT PESOS 98/100 (PHP2,949,248.98) WHICH AMOUNT SHALL BE TAKEN FROM THE 2016 EXECUTIVE BUDGET UNDER THE 20% COMMUNITY DEVELOPMENT FUND

WHEREAS, pursuant to Section 76 of RA. 9184 states that, "any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "saw no need to seek authority from the City Council prior to entering into a contract";

WHEREAS, however, to further enhance transparency and accountability the Hon. City Mayor Atty. Jaime R. Fresnedi submitted to the Sangguniang Panlungsod the Construction Agreement,

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the project construction of drainage system located at Sto. Niño Avenue, Phase 4, Sto. Niño Village, Barangay Tunasan, Muntinlupa City in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, two (2) contractors/bidders submitted letter of intent and application for eligibility, and was found eligible on December 10, 2015;

WHEREAS, the bid proposal, as read, of the participating bidder who passed the preliminary examination of bid;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, VIC VERA BUILDERS, INC., its bid proposal has been found to be responsive;

WHEREAS, the amount appropriated for the said project shall be taken from the 2016 Executive Budget under the 20% Community Development Fund;

WHEREAS, the Approved Budget for the Contract (ABC) for the project road concreting and drainage construction is Two Million Nine Hundred Fifty Eight Thousand One Hundred Seventy Five Pesos and 13/100 (Php2,958,175.13);

WHEREAS, the project was awarded to VIC VERA BUILDERS, INC., who being the responsive bidder for the project, construction of drainage system located at Sto. Niño Avenue, Phase 4, Sto. Niño Village, Barangay Tunasan, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 7<sup>TH</sup> Sangguniang Panlungsod, to authorize the City Mayor Hon. Atty. Jaime R. Fresnedi, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with VIC VERA BUILDERS, INC., for the construction of drainage system located at Sto. Niño Avenue, Phase 4, Sto. Niño Village, Barangay Tunasan, Muntinlupa City in the amount of Two Million Nine Hundred Forty Nine Thousand Two Hundred Forty-Eight Pesos and 98/100 (Php2,949,248.98) which amount shall be taken from the 2016 Executive Budget under the 20% Community Development Fund (CDF).
