A RESOLUTION AUTHORIZING THE HON. CITY MAYOR ATTY. JAIME R. FRESNEDI TO ENTER INTO AND SIGN IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA THE EXTENSION OF CONTRACT WITH METRO WASTE SOLIDWASTE MANAGEMENT CORPORATION FOR GARBAGE COLLECTION AND DISPOSAL SERVICES FOR THE MONTHS OF JANUARY 1, 2016 TO FEBRUARY 29, 2016, IN THE AMOUNT OF THIRTY TWO MILLION FORTY THOUSAND PESOS (PHP32,040,000.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2016 EXECUTIVE BUDGET.

WHEREAS, Section 48, Article XVI of Republic Act No. 9184, provides that, **"in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement, which includes: Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement"**;

WHEREAS, Section 53 of the same Article xvi, as implemented by Section 53, Rule XVI of the Revised IRR of R.A. 9184, **"authorizes Negotiated Procurement as an alternative mode of procurement in the following cases:**

"In case of imminent danger to life or property during in a state of calamity or when time is of the essence arising from actual or manmade calamities or other causes where immediate action is necessary to prevent damage to or loss of life or property or to restore vital public services, infrastructure facilities and other public utilities."

WHEREAS, one of the priority programs of the City Government of Muntinlupa is the improvement of garbage collection and disposal services in order to ensure the cleanliness of the city;

WHEREAS, the contract for the collection, hauling and disposal of garbage in the City of Muntinlupa with **Metro Waste Solidwaste Management Corporation** expired on **December 31, 2015**;

WHEREAS, the public bidding for the City Government's contract for Garbage Collection, Hauling and Disposal for 2016 was conducted by the BAC on December 29, 2015, following which post-qualification of the lowest calculated bidder was conducted and remained uncompleted until the start of the calendar year 2016;

WHEREAS, it has been recommended by the **Bids and Awards Committee (BAC)** for the City Government to enter into a **Extension of the Contract** for garbage collection, hauling and disposal with the **Metrowaste Solid Waste Management Corporation** under the **previous contract price**, prior to the award of the new contract to take effect on March 1, 2016, subject to authority from and by appropriate resolution of the city council;

WHEREAS, the **Extension of Contract** shall be effective for the interim period starting **January 1, 2016 to February 29, 2016**;

WHEREAS, the total contract price for **January 1 to February 29, 2016** is **Thirty Two Million Forty Thousand Pesos (Php32,040,000.00.00)** based on the old contract price;

WHEREAS, there is a budget appropriated for Garbage Collection and Disposal Services amounting to **One Hundred Ninety Five Million Pesos (Php195,000,000.00)** for the year 2016;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 7th Sangguniang Panlungsod of Muntinlupa, to authorize the **Hon. City Mayor Atty. Jaime R. Fresnedi**, to enter into and sign in behalf of the City Government of Muntinlupa the **Extension of Contract** with **Metro Waste Solidwaste Management Corporation** for garbage collection and disposal services for the months of **January 1, 2015 to February 29, 2015**, in the amount of **Thirty Two Million Forty Thousand Pesos (Php32,040,000.00)** which amount shall be taken from the **2016 Executive Budget**.

ADOPTED, by the 7th Sangguniang Panlungsod this day of 24th day of February, 2016, on its 19th Special Session.
