A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH CSL CONSTRUCTION CORPORATION FOR THE PROJECT CONSTRUCTION OF MULTI-PURPOSE COVERED COURT LOCATED AT STO. NIÑO VILLAGE, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF NINE MILLION EIGHT HUNDRED FIFTY NINE THOUSAND EIGHT HUNDRED EIGHTY FOUR PESOS (Php9,859,884.00) WHICH AMOUNT SHALL BE TAKEN FROM 2016 EXECUTIVE BUDGET UNDER INFRASTRUCTURE-CAPITAL OUTLAY.

**WHEREAS**, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, **“xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others”**;

**WHEREAS**, pursuant to Section 76 of RA. 9184 states that, **“any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly”**;

**WHEREAS**, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, **“saw no need to seek authority from the City Council prior to entering into a contract”**;

**WHEREAS**, however, **to further enhance transparency and accountability** the *Hon. City Mayor Atty. Jaime R. Fresnedi* submitted to the Sangguniang Panlungsod the **Construction Agreement**;

**WHEREAS**, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the project **Multi-Purpose Covered Court located at Sto. Niño Village, Barangay Tunasan, Muntinlupa City** in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

**WHEREAS**, in response to the said advertisements, two (2) contractors/bidders submitted letter of intent and application for eligibility, and one (1) was found eligible on February 11, 2016;

**WHEREAS**, one (1) bidder was submitted on February 11, 2016 and bid passed the preliminary examination of bid;

**WHEREAS**, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, CSL Construction Corporation its bid proposal has been found to be responsive;

**WHEREAS**, the amount appropriated for the said project shall be taken from the any available funds of the 2016 Executive Budget under Infra-Capital Outlay;

**WHEREAS**, the **Approved Budget for the Contract (ABC)** for the project construction ground floor conference room is **Nine Million Eight Hundred Eighty Nine Thousand Seven Hundred Eighty Pesos and 39/100 (Php9,889,780.39)**;

**WHEREAS**, the project was awarded to **CSL Construction Corporation** who being the responsive bidder for the project, **Multi-Purpose Covered Court located at Sto. Niño Village, Barangay Tunasan, Muntinlupa City**;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 7<sup>TH</sup> Sangguniang Panlungsod, to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **CSL Construction Corporation** for the project construction of **Multi-Purpose Covered Court** located at **Sto. Niño Village, Barangay Tunasan, Muntinlupa City** in the amount of **Nine Million Eight Hundred Fifty Nine Thousand Eight Hundred Eighty Four Pesos (Php9,859,884.00)** which amount shall be taken from 2016 Executive Budget under Infrastructure-Capital Outlay.
