A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH D.L. CERVANTES CONSTRUCTION CORPORATION FOR THE PROJECT CONSTRUCTION OF CONCRETING OF GROUNDS WITH DRAINAGE AND ROAD EXTENSION, MUNTINLUPA NATIONAL HIGH SCHOOL ANNEX LOCATED AT LAGUERTA, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF FIVE MILLION THREE HUNDRED NINETY FIVE THOUSAND, SIX HUNDRED SIXTY FOUR PESOS AND 60/100 (PHP5,395,664.60) WHICH AMOUNT SHALL BE TAKEN FROM THE 2015 LOCAL SCHOOL BOARD FUND-DEPED CAPITAL OUTLAY-SUPPLEMENTAL.

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others";

WHEREAS, pursuant to Section 76 of RA. 9184 states that, "any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "saw no need to seek authority from the City Council prior to entering into a contract";

WHEREAS, however, to further enhance transparency and accountability the *Hon. City Mayor Atty. Jaime R. Fresnedi* submitted to the Sangguniang Panlungsod the **Construction Agreement**,

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid for the project Concreting Of Grounds With Drainage And Road Extension, Muntinlupa National High School Annex Located At *Laguerta*, Barangay Tunasan, Muntinlupa City in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, **three (3) bidders** submitted letter of intent and application for eligibility, and one (1) was found eligible on **March 09, 2016**;

WHEREAS, **three (3) bidders** was submitted on **March 09, 2016** and the bid passed the **Preliminary Examination**;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, *D.L. Cervantes Construction Corporation* its bid has been found responsive to **Approved Budget for the Contract (ABC)**;

WHEREAS, the amount appropriated for the said project shall be taken from the 2015 Local School Board Fund-Deped Capital Outlay-Supplemental.;

WHEREAS, the **Approved Budget for the Contract (ABC)** for the project construction of Concreting Of Grounds With Drainage And Road Extension, Muntinlupa National High School Annex is Five Million, Four Hundred Ninety Four Thousand Two Hundred Sixty Five Pesos and 19/100 (**Php5,494,265.19**);

WHEREAS, the project was awarded to *D.L Cervantes Construction Corporation* who being the lowest bidder for the project, Construction Of Concreting Of Grounds With Drainage And Road Extension, Muntinlupa National High School Annex Located At *Laguerta*, Barangay Tunasan, Muntinlupa City;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 7TH Sangguniang Panlungsod, to authorize the *City Mayor Hon. Atty. Jaime R. Fresnedi*, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **D.L. Cervantes Construction Corporation** For The project Concreting Of Grounds With Drainage And Road Extension, Muntinlupa National High School Annex Located At *Laguerta*, Barangay Tunasan, Muntinlupa City In The Amount Of Five Million Three Hundred Ninety Five Thousand, Six Hundred Sixty Four Pesos And 60/100 (**Php5,395,664.60**) Which Amount Shall Be Taken From The 2015 Local School Board Fund-Deped Capital Outlay-Supplemental.






