WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances":

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned";

WHEREAS, the Department of Social Welfare and Development (DSWD) – National Capital Region (NCR) is the lead agency in the implementation of the Social Pension for Indigent Senior Citizens (SPISC) to augment the daily subsistence and other medical needs of Filipino indigent senior citizens;

WHEREAS, the Social Pension for Indigent Senior Citizens (SPISC) is an additional government assistance provided under Republic Act 9994 otherwise known as "expanded Senior Citizens Act 2010", an Act granting additional benefits and privileges to senior citizens;

Leyson, Regional Director Of The Department Of Social Welfare And Development (DSWD)-National Capital Region (NCR) in the distribution of cash grants to Social Pension For Indigent Senior Citizens (SPISC) beneficiaries.
