WHEREAS, Section 458 (a)(I)(iv), of the Local Government Code of 1991 states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxxx and appropriate funds for the general welfare of the city and its inhabitants xxx, and":

(I)(iv) shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

WHEREAS, on April 19, in Km. 25 Napocor Road, Barangay Alabang Muntinlupa City, a fire totally destroyed houses and affected families;

**WHEREAS,** the owner of the houses, renters, and sharers/boarders were rendered homeless by reason of the said conflagration;

**WHEREAS**, the Social Services Department (SSD) recommended to declare the affected area as in <u>a state of calamity</u>;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the members of the 8<sup>th</sup> Sangguniang Panlungsod, to declare the area affected by the conflagration on April 19, in Km. 25 Napocor Road, Barangay Alabang, Muntinlupa City, as in a State of Calamity.

ADOPTED, by the  $8^{th}$  Sangguniang Panlungsod of Muntinlupa, this  $24^{th}$  day April 2017, on its  $5^{th}$  Special Session.
