RESOLUTION DIRECTING MAYNILAD TO TEMPORARILY SUSPEND THE CONSTRUCTION AND DRILLING ACTIVITIES AT PUROK 6, BARANGAY CUPANG, MUNTINLUPA CITY AND REQUESTING THE ENGINEERING OFFICE TO CONDUCT INVESTIGATION OF THE COLLAPSED RESIDENTIAL HOUSE AND THE DAMAGE TO ADJACENT STRUCTURES.

WHEREAS, Section 458 (a)(I)(iv), of the Local Government Code of 1991 states that, "the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxxx and appropriate funds for the general welfare of the city and its inhabitants xxx, and":

(I)(iv) shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.

WHEREAS, on April 24, 2017, a house owned by one Juanita Alipid, collapsed Barangay Cupang, Muntinlupa City, and two (2) nearby houses also suffered damage;

WHEREAS, prior to the incident, an excavation work is being undertaken by the Maynilad Water Services and Dragon Health Corporation on the same area;

WHEREAS, initial observations pointed to the possibility of ground subsidence as the sewerage project was removing soil nearby which was aggravated by several days of rain that may have cause softening and mobility of the foundation soil;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the members of the 8th Sangguniang Panlungsod, to direct Maynilad Water Services to temporarily suspend the construction and drilling activities at Purok 6, Barangay Cupang, Muntinlupa City and requesting the Engineering Office to conduct investigation of the collapsed residential house and the damage to adjacent structures.

RESOLVE FURTHER, that the Maynilad Water Services be likewise directed to institute safety measures on all its excavation works in the entire city;
