WHEREAS, the *Muntinlupa Scholarship Foundation*, the implemetor of the *Muntinlupa Scholarship Program (MSP)* of the City Government of Muntinlupa, disburses to almost 40,000 beneficiaries the financial grant of students which amount varies based on the categories indicated in the scholarship ordinances;

WHEREAS, efficiency dictates that a system for smooth and convenient distribution of benefits to scholars be institutionalized as this would arrest risky cash releases and do away with tedious hours of queing by the scholars;

WHEREAS, PayMaya a corporation organized under the Philippine laws offered an electronic system through the creation of a settlement account for the City of Muntinlupa which shall be used as source account for processing disbursement of the scholars;

WHEREAS, finding the said offer beneficial and advantageous to the City, the Local Finance Committee of the City of Muntinlupa adopted *Resolution No. 2, Series of 2017*, recommending the use of PayMaya Debit Cards for the Muntinlupa Scholarship Program's transition from manual to Electronic Allowance Disbursement;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 8<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to authorize the *Hon. City Mayor Atty. Jaime R. Fresnedi* in behalf of the *City Government of Muntinlupa* to enter and sign the disbursement services agreement with *PayMaya Philippines, Inc.*, for the disbursement services agreement for the use of *PayMaya Debit Cards* for the *Muntinlupa Scholarship Program's* electronic allowance disbursement.


