A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH KME DESIGN & CONSTRUCTION FOR THE PROJECT CONSTRUCTION OF PERIMETER FENCE AND GATE OF BULILIT CENTER LOCATED AT LAGUERTA, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF ONE MILLION EIGHT TWENTY TWO THOUSAND EIGHT HUNDRED FIFTY SEVEN PESOS AND 60/100 (PHP1,822,857.60) WHICH AMOUNT SHALL BE TAKEN FROM 2017 EXECUTIVE BUDGET UNDER THE 5% GENDER AND DEVELOPMENT (GAD) ENGINEERING-CAPITAL OUTLAY.

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others";

WHEREAS, pursuant to Section 76 of RA. 9184 states that, "any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";

WHEREAS, pursuant to the provisions of Republic Act 9184, Section 37, paragraph 2, Section 37.3, Section 38.1 of the same Act, "saw no need to seek authority from the City Council prior to entering into a contract";

WHEREAS, however, to further enhance transparency and accountability the Hon. City Mayor Atty. Jaime R. Fresnedi submitted to the Sangguniang Panlungsod the Construction Agreement;

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the construction of **perimeter fence and gate of Bulilit Center** located at **Laguerta, Barangay Tunasan, Muntinlupa City**, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, two (2) bidders submitted letter of intent and application for eligibility and was found eligible on **April 19, 2017**;

WHEREAS, one (1) Bidder who submitted their Bid on **April 19, 2017** and bid passed the Preliminary Examination of Bid at the *City Administrator Conference Room, 2nd Floor City Hall Main Building, National Road, Barangay Putatan, Muntinlupa City*.

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, **KME DESIGN & CONSTRUCTION** its bid has been found to be responsive to **Approved Budget for the Contract (ABC)** amounting to **One Million Eight Hundred Thirty One Thousand Four Hundred Seventy Six Pesos and 31/100 (Php1,831,476.31)**;

WHEREAS, the amount of **One Million Eight Hundred Twenty Eight Hundred Fifty Seven and 60/100 (Php1,822,857.60)** shall be taken from the **5% Gender and Development (GAD) – Engineering Capital Outlay** ;

WHEREAS, the project was awarded to **KME Design & Construction** who being the lowest bidder for the project construction of **perimeter fence and gate of Bulilit Center** located at **Laguerta, Barangay Tunasan, Muntinlupa City**;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **8TH Sangguniang Panlungsod**, to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **KME Design & Construction** for the project construction of **perimeter fence and gate of Bulilit Center** located at Laguerta, Barangay Tunasan, Muntinlupa City in the amount of One Million Eight Twenty Two Thousand Eight Hundred Fifty Seven Pesos and 60/100 (Php1,822,857.60) which amount shall be taken from 2017 Executive Budget under the **5% Gender and Development (GAD) Engineering-Capital Outlay**.




