FRESNEDI IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH PHILIPPINE LONG DISTANCE TELEPHONE (PLDT) FOR THE PROJECT PLDT SNAP INSTALLATION AND CONFIGURATION OF NETWORK GATE WAY AND EMAIL SERVER.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, the Management Information System (MIS) Office, OIC wrote a letter to Hon. City Mayor Atty. Jaime R. Fresnedi informing the City Mayor, the City Government's existing contract with PLDT SNAP Management Server Solution of the internet connectivity management program has already expired and is requesting for a new contract to avoid disruptions in service;

WHEREAS, on July 9, 2012 the Sangguniang Panlungsod approved Resolution No. 12-206 authorizing the former City Mayor Aldrin L. San Pedro to enter into a Memorandum of Agreement MOA between the Philippine Long Distance (PLDT);

WHEREAS, on October 9, 2017, the City Mayor Hon. Atty. Jaime R. Fresnedi, endorsed to the Sangguniang Panlungsod the contract of PLDT Snap Management Server Solution and two (2) PLDT i-Gate Upgrade of Internet Bandwidth;

WHEREAS, on **September 27, 2017**, the Local Finance Committee approved Resolution No. 18, Series of 2017, recommending the PLDT, Inc., proposal for Muntinlupa PLDT Snap Installation and configuration of Network Gateway and Email, Server;

WHEREAS, the PLDT Snap Installation and configuration of Network Gateway and Email Server has already expired on December 2015, and requesting for a new contract to avoid disruptions in service;

WHEREAS, there are three companies have submitted their proposals for network gateway, email, proxy, content filtering and firewall, they are the following:

- a) *Philippine Long Distance Incorporated (PLDT)*
- b) *Mara Linux and Business Solutions Inc.*
- c) *Terrasoft*

WHEREAS, after careful consideration of those concerned, with recommendation from the Management Information Systems (MIS) Office, PLDT still offers the most comprehensive service with regard to network gateway and email solution;

WHEREAS, The project cost is amounting to **Sixty Nine Thousand Three Hundred Seventy Eight Pesos (Php69,378.87)** monthly for Three (3) years or Thirty Six (36) months;

WHEREAS, the Terms and Condition of the **Memorandum of Agreement (MOA)** shall be formed part of this Resolution;

WHEREAS, there is an available fund from the 2017 Executive Budget;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 8th Sangguniang Panlungsod of Muntinlupa, to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi** in behalf of the City Government of Muntinlupa to enter into a **Memorandum of Agreement (MOA)** with **Philippine Long Distance Telephone (PLDT)** for the project PLDT Snap Installation and Configuration of Network Gate Way and Email Server.

RESOLVED FURTHER, that the Bids and Awards Committee (BAC) and General Services Office (GSO) shall submit and certify that the award to the **Philippine Long Distance Telephone (PLDT)** complies with the Procurement Act Law.

FINALLY RESOLVED, that the **Memorandum of Agreement (MOA)** shall submit to the Legal Office for any legal opinion.

APPROVED, by the 8th **Sangguniang Panlungsod of Muntinlupa**, this 6th day of **November, 2017** on its 55th **Regular Session**.
