WHEREAS, the Local Finance Committee approved Resolution No. 5, Series of 2017, recommending the City Government of Muntinlupa to enter into a Memorandum of Agreement (MOA) with the **Social Security System (SSS)** to ensure coverage and contribution of the Job Order (JO) and other voluntary personnel of the City Government of Muntinlupa;

WHEREAS, the proposed Memorandum of Agreement (MOA) the Job Order (JO) personnel who are not governed by the GSIS Law, will be entitled to the benefits and protection afforded to **Social Security System (SSS)** members and their beneficiaries such as insurance against the **hazards of disability, sickness, maternity, old-age, death and other contingencies** resulting from loss of income or financial burden;

WHEREAS, the **Social Security System (SSS)** is continually aiming to extend its mandate to provide social security protection to all workers in the private sector, which include the employed workers, overseas Filipinos, self employed, professionals and those in the informal sector;

WHEREAS, among the identified workers who are subject to **Social Security System (SSS)** self-employed coverage are the **Job Order (JO)** personnel engage by the government through **contract of service** are not covered under the GSIS Law;
