FRESNEDI TO IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA THROUGH THE OFFICE OF THE SENIOR CITIZENS AFFAIRS (OSCA) TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT WITH ASIAN HOSPITAL CHARITIES, INC., ON THE ONE TIME HEARING TEST AND CONSULTATION FOR THE SENIOR CITIZENS OF MUNTINLUPA,

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, **"the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"**;

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, **"xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned"**;

WHEREAS, the Asian Hospital Charities, Inc., is the official arm of Asian Hospital Inc., (AHI) which owns and operate the Asian Hospital and Medical Center (AHMC);

WHEREAS, the City Government of Muntinlupa through Office for Senior Citizens Affairs (OSCA) and Asian Hospital Charities, Inc., (AHCi) agreed to refer qualified Senior Citizen patients to undergo the following:

1. **A one-time hearing test (Puretone Audiometry, Speech Audiometry, and Tympanometry);**
2. **Consultation with the Outpatient Health Services (OHS) of AHMC through the assistance of AHCi;**

WHEREAS, some of the Procedures for the said MOA are the following:

1. The **Office for Senior Citizens Affairs (OSCA)** staff be in charge of identifying the most deserving underprivileged Senior Citizens who will undergo the hearing test and the consultation;
2. The **Office for Senior Citizens Affairs (OSCA)** staff shall notify AHCI and the hearing and dizziness Unit of AHMC of the qualified Senior Citizens who will undergo initial consultation with an otorhinolaryngology (ENT) and who will undergo the needed diagnostic procedure; The **Office for Senior Citizens Affairs (OSCA)** staff will accompany the Senior Citizens to the hearing and dizziness Unit of AHMC on the date of visit;
3. The Hearing and Dizziness Unit will accept OSCA –referred patients on the following schedule herein provided. No walk-in patients will be accommodated by AHCI and Hearing and dizziness Unit:

Procedure	Wednesday	Friday
ENT Screening	9:00-10:30am	9:00am-10:30am
Hearing Test	10:00am-5:00pm	10:00am-5:00pm

WHEREAS, all expenses incurred by the Senior Citizen (which are payable to AHI) in undergoing the hearing test and/or consultation at AHMC shall be shouldered by OSCA and AHCI in accordance with the subsidy sharing scheme provided in the **Memorandum of Agreement (MOA)**;

WHEREAS, the payments by **Office for Senior Citizens Affairs (OSCA)** under the agreement shall be made through checks issued by the City of Muntinlupa payable to Asian Hospital Inc., for the account of the qualified Senior Citizens;

WHEREAS, the Memorandum of Agreement (MOA) shall form-part of this Resolution;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 8th Sangguniang Panlungsod of Muntinlupa, to authorize the **Hon. City Mayor Atty. Jaime R. Fresnedi** to in behalf of the City Government of Muntinlupa through **Office of the Senior Citizens Affairs (OSCA)** to enter and sign the **Memorandum of Agreement (MOA)** with **Asian Hospital Charities, inc., (AHCi)** on the one time hearing test and consultation for the Senior Citizens of Muntinlupa.

APPROVED, by the 8th Sangguniang Panlungsod of Muntinlupa this 27th day of November, 2017 on its 57th Regular Session.
