WHEREAS. Section 31 paragraph 3 of Presidential Degree (PD) 957 as amended by PD 1216 which states that, upon their completion as certified to by the authority the roads, alleys, sidewalks and playgrounds shall be donated by the owner or developer to the city or municipality and it shall be mandatory for the local governments to accept provided, however, that the parks and playgrounds may be donated to the Homeowners' Association of the project with the consent of the city or municipality concerned. No portion of the parks and playgrounds donated thereafter shall be converted to any other purpose or purposes";

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the same code, provides that, "the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Fanlungsod or pursuant to law or ordinances";

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Vocal Government Code of 1991, states that, "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned";

WHEREAS, the registered owner of the roads lot/s and open spaces of Pleasant Village is the estate of Felisa Tamio de Buenaventura (represented by Bella Guerrero) and the estate of Felimon Buenaventura St. (Represented by Rodolfo Mariano) have turned-over to Pleasant Village Homeowners Association the road lots and open spaces covered by TCT Nos. 093509 (formerly TCT No.464530), TCT No. 79467 (formerly TCT No.464676), and TCT No. 79489 (for road lots 1 to 10) all of from the Registry of Muntinlupa:

WHEREAS, Pleasant Village Homeowners Association, Inc., being the Donee of the said properties, is desirous of turning-over the abovementioned road lots and open spaces to the City Government of Muntinlupa for purposes of road repair/constructions, road right of way, Maynilad water connection and other similar lawful purposes;

WHEREAS, Pleasant Village Homeowners Association through a Board Resolution requested to declare the whole Pleasant Village as open subdivision, an important requirement in order to facilitate the installation/laying of pipe water supply by Manila Waterworks Sewerage System (MWSS) and its concessionaire Maynilad Water Services, Inc., on an individual house connection basis;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 8th Sangguniang Panlungsod of Muntinlupa, to authorize the City Mayor Hon. Atty. Jaime R. Fresnedi in behalf of the City Government of Muntinlupa to accept and sign the Deed of Donation of Road Lots and open spaces and deciare the whole Pleasant Village as an open subdivision.
