A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ATTY. JAIME R. FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH ODD KONSTRUCTION BUILDERS INC., FOR THE PROJECT CONSTRUCTION OF NATIONAL CHILD DEVELOPMENT CENTER LOCATED AT STO. NIÑO VILLAGE, BARANGAY TUNASAN, MUNTINLUPA CITY AMOUNTING TO TWO MILLION TWO HUNDRED NINETY EIGHT THOUSAND FOUR HUNDRED FIFTY TWO PESOS AND 91/100 (PHP2,298,452.91) WHICH AMOUNT SHALL BE FUNDED BY THE NATIONAL GOVERNMENT.

WHEREAS, pursuant to Section 76 of RA. 9184 states that, “*any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly*”;

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, “*the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances*”;

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the project construction of **National Child Development Center located at Sto. Niño Village, Barangay Tunasan, Muntinlupa City** in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and likewise, City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, one (1) bidder submitted letter of intent and application for eligibility, and one (1) was found eligible on January 23, 2018;

WHEREAS, lone (1) bidder were submitted on January 23, 2018 and one bidder passed the preliminary examination of bid;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, **Odd Konstruction Builders Inc.,** its bid proposal has been found to be responsive;

WHEREAS, the amount appropriated for the said project shall be funded by the National Government;

WHEREAS, the **Approved Budget for the Contract (ABC)** for the project construction of **National Child Development Center**, is **Two Million Two Hundred Ninety Eight Thousand Four Hundred Fifty Two Peso and 91/100 (Php2,298,452.91);**

WHEREAS, the project was awarded to **Odd Konstruction Builders Inc.,** who being the responsive bidder for the project, construction of **National Child Development Center located at Sto. Niño Village, Barangay Tunasan, Muntinlupa City;**

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 8TH Sangguniang Panlungsod, to authorize the **City Mayor Hon. Atty. Jaime R. Fresnedi**, in behalf of the City Government of Muntinlupa to enter into a Construction Agreement with **Odd Konstruction Builders Inc.,** for the project construction of **National Child Development Center located at Sto. Niño Village, Barangay Tunasan, Muntinlupa City** amounting to **Two Million Two Hundred Ninety Eight Thousand Four Hundred Fifty Two Pesos and 91/100 (Php2,298,452.91)** which amount shall be funded by the National Government.
