WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, ***“xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned”***;

WHEREAS, on **April 4, 2018**, the Committee on Engineering Public Works and Infrastructure conducted public hearing with regards to the Memorandum of Agreement (MOA) between the City Government of Muntinlupa and the Las Piñas-Muntinlupa District Engineering Office of the Department of Public Works and Highways (DPWH) for the following Local Infrastructure Projects:

**NOW THEREFOR, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the 8<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to ratify the **Memorandum Of Agreement (MOA)** entered into and signed by the **City Mayor Atty. Jaime R. Fresnedi** in behalf of the City Government of Muntinlupa with the **Las Piñas-Muntinlupa District Engineering Office of the Department of Public Works and Highways (DPWH)** on the construction of Infrastructure Projects within the jurisdiction of Muntinlupa City.


