WHEREAS, Section 16, Chapter 2, Title One, Book 1 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 provides for the general welfare clause which states that, ***“the local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort convenience of their inhabitants.”***

WHEREAS, on March 16, 2015, 7th Sangguniang Panlungsod approved Resolution No. 15-205, entitled, ***“A Resolution Authorizing The Hon. City Mayor Atty. Jaime R. Fresnedi To Enter Into And Sign In Behalf Of The City Government Of Muntinlupa A Memorandum Of Agreement Between The City Government Of Muntinlupa And Lingkod Muntinlupa Foundation For The Implementation Of A Care Card Project Wherein Medical Or Health Benefits Offered By The City To Its Constituents Shall Be Made Card-Based”***.

WHEREAS, the Lingkod Muntinlupa Foundation (LMF), headed by its President Dra. Teresita Filoteo, is a non-profit and non-stock corporation which issues Muntinlupa Care Card (MCC) to Muntinlupeños and maintains the cardholders' database with the responsibility of protecting the privacy rights of its cardholders and using it only for purposes allowed by its cardholders;

WHEREAS, there is a need to have additional means of personal identification of citizens of Muntinlupa City especially those who are unable to obtain any other valid government issued IDs because of absence or deficiency in the requirements while the Muntinlupa Care Card uses easy steps to avail of the MCC ID by the Muntinlupeños and is completely voluntary on the part of the applicant;

WHEREAS, the Muntinlupa Care Card project is an effective tool in identifying the veracity of the identity of its MCC members who are residents or registered voters of Muntinlupa City and helps in assisting the City Government in granting financial, educational and health assistance, including free public transport to the citizens of Muntinlupa;

WHEREAS, to facilitate the processing of other optional assistance programs to Muntinlupa constituents, the Muntinlupa Care Card can be relied upon as one of the identification cards that can serve to verify the true identity of the cardholder-applicant;

WHEREAS, the Muntinlupa Care Card shall henceforth be recognized as an official valid local government identification card acceptable for the purpose of processing local government transaction, programs and activities of the City Government of Muntinlupa whenever valid Identification Cards are required for presentation to complete a government transaction, program or activity;

WHEREAS, private establishment doing business or operating within the jurisdiction of Muntinlupa City shall officially accept the Muntinlupa Care Card as a valid government identification card whenever such is required to verify or authenticate the identity of a person involved in each transaction;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by 8th Sangguniang Panlungsod of Muntinlupa, to recognize the Muntinlupa Care Card as a valid Identification Card of Muntinlupa constituents for purposes of processing Local Government transactions, programs and activities.


