FRESNEDI, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO ENTER INTO A CONSTRUCTION AGREEMENT WITH CSL CONSTRUCTION CORPORATION FOR THE PROJECT CONSTRUCTION OF CUPANG HEALTH CENTER (PHASE 1) LOCATED AT BARANGAY CUPANG, MUNTINLUPA CITY IN THE AMOUNT OF NINE MILLION SIX HUNDRED EIGHTY THOUSAND NINE HUNDRED EIGHTY NINE PESOS AND 73/100 (PHP9,680,989.73) WHICH AMOUNT SHALL BE SHOULDERED BY THE DEPARTMENT OF HEALTH-NATIONAL CAPITAL REGION (DOH-NCR).

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "**the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances**";

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the project construction of *Cupang Health Center (Phase 1) Located at Barangay Cupang, Muntinlupa City* in a newspaper of general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and likewise posted the same in conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, one (1) bidder submitted letter of intent and application for eligibility and was found eligible on **March 27, 2018**;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, **CSL Construction Corporation** its bid has been found to be responsive to **Approved Budget for the Contract (ABC)** amounting to Nine Million Six Hundred Ninety Nine Thousand Six Hundred Seventy Eight Pesos and 73/100 (**Php9,699,678.73**);

WHEREAS, the **General Appropriations Act (GAA)** for the Fiscal Year 2016 wherein the amount of **Twenty Million, Nine Hundred Eighty Thousand Pesos (Php20,980,000.00)** is allocated for the Local Government of Muntinlupa City with the purpose of expansion/construction for the following **Rural Health Units (RHUs)**:
