WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government Code of 1991, states that, "xxx no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned";

WHEREAS, for the Local Government Support Fund (LGSF) Assistance to cities, the City Government of Muntinlupa proposed one development project in the Alabang Viaduct which is located along the convergence zone to achieve the long-term sustainability of restoring and enhancing people's positive relationship with nature in the built-up environment;

WHEREAS, the Department of Budget and Management (DBM) has allotted funding assistance to the City Government of Muntiniupa amounting to Seventeen Million Two Hundred Ninety Thousand Seven Hundred Fifty Four Pesos (Php17,290,754.00) for the project Development of Aiabang Viaduct located at Barangay Alabang, Muntinlupa City;
