WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor shall represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, Rule IX, Article 47 of the Rules and Regulations Implementing the Local Government of 1991, states that, "xxx no contract may be entered into by the Local Government Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned";

WHEREAS, on February 8, 2019, the Committee on Public Order, Security and Safety conducted a public hearing with the agenda entitled, "extension of contract between the city government of Muntinlupa and Best Security Agency";

WHEREAS, the 2018 Security & Protection Services contract between the City Government of Muntinlupa and Best Security Agency has a duration of until December 31, 2018;

WHEREAS, a public bidding for the 2019 Security & Protection Services contract has been substantially undertaken, however, the Bids and Awards Committee did not receive any bid until deadline, causing the failure of bidding;


