ORDINANCE NO. 2022-026

AN ORDINANCE GRANTING FINANCIAL ASSISTANCE IN THE TOTAL AMOUNT OF SEVENTY-FIVE THOUSAND EIGHT HUNRED PESOS (PHP75,800.000) TO THE THREE (3) FAMILIES RESIDING AT KATIHAN ST. BARANGAY POBLACION, MUNTINLUPA CITY WHO WERE AFFECTED BY A WRIT OF DEMOLITION ISSUED BY THE METROPOLITAN TRIAL COURT (MTC) BRANCH 112 WHICH AMOUNT SHALL BE TAKEN FROM THE 2022 EXECUTIVE BUDGET UNDER THE SOCIALIZED HOUSING, LANDBANKING, COMMUNITY MORTGAGE PROGRAM AND OTHER RELATED ACTIVITIES UNDER THE NON OFFICE-MOOE

WHEREAS, Section 458 (a) (1) (iv) of the Local Government Code of 1991 states that, ***"The Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, adopt resolutions and appropriate funds for the general welfare of the city and its inhabitants xxx"***;

WHEREAS, pursuant to Article VII, Section 28(8), of UDHA Law, states that, ***"Eviction and Demolition. – Eviction or demolition as a practice shall be discouraged. Eviction or demolition, however, may be allowed under the following situations: Adequate relocation, whether temporary or permanent: Provided, however, That in cases of eviction and demolition pursuant to a court order involving underprivileged and homeless citizens, relocation shall be undertaken by the local government unit concerned and the National Housing Authority with the assistance of other government agencies within forty-five (45) days from service of notice of final judgment by the court, after which period the said order shall be executed: Provided, further, That should relocation not be possible within the said period, financial assistance in the amount equivalent to the prevailing minimum daily wage multiplied by sixty (60) days shall be extended to the affected families by the local government unit concerned"***;

WHEREAS, the Metropolitan Trial Court Branch 112 issued a Writ of Execution directing the Sheriff to execute the dispositive portion of the MTC' decision which reads, ***"Wherefore finding the Compromise Agreement to be not contrary to law, morals and good customs, and public policy or public order, the same is hereby approved and adopted as the Decision of the court. The parties are enjoined to strictly abide by the terms thereof"***;

WHEREAS, the above mentioned Writ of Execution affected three (3) families out of which **two (2) family** appear in the UDHA Master list of Potential beneficiaries in Katihan St., Barangay Poblacion and the remaining **one (1)** family were not included in the said list;

WHEREAS, pursuant to Section 28, Article VII of UDHA, the following informal settlers: **Adelino Caluag** and **Fernando Mendoza** shall be granted financial assistance equivalent to **sixty (60) days minimum wage** computed as follows: two (2) persons multiplied by P590 multiplied by 60 days or **Seventy Thousand Eight Hundred Pesos (Php70,800.00)** and the one (1) non-UDHA Informal Settler Family, for humanitarian reasons, may be granted **Five Thousand Pesos (Php5,000.00)** or the total amount of **Seventy-Five Thousand Eight Hundred Pesos (Php75,800.00)**;

WHEREAS, the total amount of **Seventy-Five Thousand Eight Hundred Pesos (Php75,800.00)** is certified by the **Budget Office** as available fund from the **2022 Executive Budget** under the Socialized Housing, Land Banking, Community Mortgaged Program and other Related Activities under the Non-Office MOOE;

NOW BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 10th Sangguniang Panlungsod, to grant of **Financial Assistance** in the total amount of **Seventy-Five Thousand Eight Hundred Pesos (Php75,800.000)** to the three (3) families residing at **Katihian Street, Barangay Poblacion** who were affected by a **Writ of Demolition** issued by the **Metropolitan Trial Court (MTC) Branch 112** which amount shall be taken from the 2022 Executive Budget under the Socialized Housing, Land Banking, Community Mortgage Program and Other Related Activities under the Non Office-MOOE.

ENACTED, by the 10th **Sangguniang Panlungsod of Muntinlupa** this 28th day of **November 2022**, on its 21st Regular Session.
