ORDINANCE NO. 2022-030

AN ORDINANCE PRESCRIBING AN INCREASE IN THE HEALTH CERTIFICATE FEE BEING IMPOSED UPON INDIVIDUALS EMPLOYED IN BUSINESSES CATERING TO THE TRAVELLING PUBLIC AND THOSE EMPLOYED IN THE FOOD ESTABLISHMENTS

**WHEREAS**, Republic Act No. 7160, otherwise known as the Local Government Code (LGC) of 1991, states that, ***“Local government units are empowered to enact regulatory ordinances with the end in view of promoting the health and welfare of their constituents”***;

**WHEREAS**, Presidential Decree No. 522 signed on July 30, 1974 also known as the Decree Prescribing Sanitation Requirements For The Operation Of Establishments provides that, ***“The Regional Sanitation Committees, in consultation with Provincial and City Health Officers, are hereby vested with, but not limited to, the following powers and functions: a) Require all business establishments catering to the travelling public to have the necessary sanitary permits to operate; b) Require employees of such establishments to possess health certificates issued by the local health officials;***

**WHEREAS**, Section 15 of the Code on Sanitation or Presidential Decree No. 856 signed on December 23, 1975 likewise provides, ***“No person shall be employed in any food establishment without a Health Certificate issued by the local health authority. This certificate shall be issued only after the required physical and medical examinations are performed and immunizations are administered at prescribed intervals”***;

**WHEREAS**, the City of Muntinlupa by virtue of its power embodied in the LGC of 1991 and through the Sangguniang Panlungsod, enacted its own revenue ordinance/s to govern the practice of profession;

**WHEREAS**, Ordinance 93-35 or the Revenue Code of Muntinlupa, as amended, provides for the imposition of an annual fee for the issuance health certificates as sine-qua-non before a person/individual can practice profession of calling in establishments catering to the travelling public and those employed in the food establishments;

**WHEREAS**, while the number affected employees in the professions being mentioned in this ordinance are those who receive minimum daily wage, it is necessary to impose regulatory controls for the general welfare of the constituents;

**WHEREAS**, under the current condition, the ONE HUNDRED PESO (Php100.00)-fee being imposed is outdated as its last revision was in 2002 or twenty years after where the prices of materials and supplies for its production has increased drastically;

**NOW THEREFORE, BE IT ORDAINED, AND HEREBY ORDAINED**, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, in Session assembled that:

**SECTION 1. Title** - This ordinance shall be known "**HEALTH CERTIFICATE FEE INCREASE**";

**SECTION 2. Increase**. All persons required by existing laws, rules, and regulations to secure health certificate from the City Health Office shall pay an annual fee of **One Hundred Fifty Pesos (Php150.00)**.

**SECTION 3. Repealing Clause** – All ordinances and local executive orders or parts thereof which are inconsistent with any part of the provisions of this ordinance is hereby repealed or amended accordingly.

**SECTION 4. Separability Clause** – If, for any reason or reasons, any part or provisions of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

**SECTION 5. Effectivity Clause** – this ordinance shall take effect upon its approval.

**ENACTED**, by the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, this 12<sup>th</sup> day of June 2018, on its 23<sup>th</sup> Regular Session.




