WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the Supply & Delivery of Grocery Items para sa Batang may K Program and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Million Seven Hundred Ninety Thousand Pesos (P1,790,000.00) (hereinafter called "the Contract Price").


