

### Contract Agreement

THIS AGREEMENT made the \_\_\_\_ day of ~~MAY~~ **05 2013** 20\_\_\_\_ between **CITY GOVERNMENT OF MUNTINLUPA** of the Philippines (hereinafter called "the Entity") of the one part and **ISHA GLOBAL DISTRIBUTION CORPORATION** with address at Muntinlupa City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the **Supply & Delivery of Ultra Low Volume (ULV) Fogging Machine & Oil-Proof High Performance Sprayer** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Two Million Four Hundred Forty One Thousand One Hundred Pesos (P2,441,100.00)**(hereinafter called "the Contract Price").

  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;



- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **Two Million Four Hundred Forty One Thousand One Hundred Pesos (P2,441,100.00)** or such other sums as may be ascertained, **ISHA GLOBAL DISTRIBUTION CORPORATION** agrees to the **Supply & Delivery of Ultra Low Volume (ULV) Fogging Machine & Oil-Proof High Performance Sprayer** in accordance with his/her/its Bid.
4. The City Government of Muntinlupa agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.



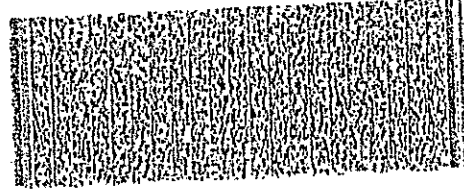
