AN ORDINANCE GRANTING THE TOTAL AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (PHP150,000.00) OF FINANCIAL ASSISTANCE TO THE FIVE (5) FAMILIES AFFECTED BY FIRE ON MARCH 24, 2023 AT NO. 114 BANABA STREET, AYALA ALABANG VILLAGE, BARANGAY AYALA ALABANG, MUNTINLUPA CITY

WHEREAS, Section 16 of the Local Government Code of 1991 states that *“Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”*:

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, *“The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx”*;

WHEREAS, on *March 24, 2023* One (1) structures, consisting of *Five (5) families*, were gutted by fire at *No. No. 114 Banaba Street, Ayala Alabang Village, Barangay Ayala Alabang, Muntinlupa City*;

WHEREAS, in a final report rendered by the *Social Services Department* on *March 27, 2023*, the following were noted as casualties of the said fire:

1. *One (1) structure;*
2. *Five (5) families;*
3. *Twenty-Two (22) individuals;*
4. *Two (2) Senior Citizens;*
5. *One (1) Children (0-5 years old);*

WHEREAS, the **Social Service Department (SSD)** of the City of Muntinlupa and the **Barangay Chairman of Ayala Alabang**, conducted a survey on the victims of the fire to determine the homeowners, renters and sharers, basing the category of victims in accordance with prevailing ordinances, a recommendation on the matter that would entail a total amount of **One Hundred Fifty Thousand Pesos (Php150,000.00)** financial assistance to be distributed as follows:

FURTHER, that the **Final Disaster Report** dated **March 27, 2023 CN: 2023-006** issued by the **Social Services Department (SSD)** shall form part of this ordinance.
