WHEREAS, on March 27, 2023 Three (3) structures, consisting of Four (4) families, were gutted by fire at Phase 3, Block 48, Lot 12 & 13 Southville 3, NHA, Barangay Poblacion, Muntinlupa City;

WHEREAS, in a final report rendered by the Social Services Department on March 28, 2023, the following were noted as casualties of the said fire:

1. Three (3) structures;

2. Four (4) families;

3. Nineteen (19) individuals;

4. Two (2) Children (0-5 years old);




