AN ORDINANCE GRANTING THE TOTAL AMOUNT OF SIXTY THOUSAND PESOS (PHP60,000.00) OF FINANCIAL ASSISTANCE TO THE TWO (2) FAMILIES AFFECTED BY FIRE ON MARCH 30, 2023 AT BLOCK 22 LOT 16 SOLDIER'S HILLS VILLAGE, BARANGAY PUTATAN, MUNTINLUPA CITY

WHEREAS, Section 16 of the Local Government Code of 1991 states that **"Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessarily appropriate, incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare"**:

WHEREAS, Section 458 (a)(1)(iv) of the Local Government Code of 1991 provides that, **"The Sangguniang Panlungsod shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities and provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood xxx"**;

WHEREAS, on **March 30, 2023** One (1) structure, housing **Four (4) families**, were gutted by fire at **Block 22 Lot 16 Soldier's Hills Village, Barangay Putatan, Muntinlupa City**;

WHEREAS, in a final report rendered by the **Social Services Department** on **April 3, 2023**, the following were noted as casualties of the said fire:

1. **One (1) structure;**
2. **Two (2) families;**
3. **Seventeen (17) individuals;**

WHEREAS, the **Social Service Department (SSD)** of the City of Muntinlupa and the **Barangay Chairman of Putatan**, conducted a survey on the victims of the fire to determine the homeowners, renters and sharers, basing the category of victims in accordance with prevailing ordinances, a recommendation on the matter that would entail a total amount of **Sixty Thousand Pesos (Php60,000.00)** financial assistance to be distributed as follows:


