WHEREAS, on March 30, 2023 One (1) structure, housing Four (4) families, were gutted by fire at Block 22 Lot 16 Soldier's Hills Village, Barangay Putatan, Muntiniupa City;

WHEREAS, in a final report rendered by the Social Services Department on April 3, 2023, the following were noted as casualties of the said fire:

1. One (1) structure;

2. Two (2) families;

3. Seventeen (17) individuals;




