AN ORDINANCE ADOPTING THE LOCAL RISK REDUCTION MANAGEMENT COUNCIL (LDRRMC) RESOLUTION NO 3 SERIES OF 2023 AND APPROVING THE UTILIZATION OF A PORTION OF THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (LDRRMF) CONTINUING APPROPRIATIONS IN THE AMOUNT OF TWO HUNDRED TWENTY-THREE MILLION EIGHTEEN THOUSAND THREE HUNDRED NINETY-TWO PESOS (PHP223,018,392.00)

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that, ***"Every Local Government Unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;"***

WHEREAS, Section 2(i) of the Philippine Disaster Risk Reduction and Management Act of 2010 (R.A. No. 10121) declares that, ***"it is the policy of the State to recognize and strengthen the capacity of the LGUs and communities in mitigating and preparing for, responding to, and recovering from the impact of disasters,"***;

WHEREAS, under RA 10121, a Local Disaster Risk reduction Management Council (LDRRMC) is created with functions among others: ***(1) Approve, monitor and evaluate the implementation of the LDRRMPs and regularly review and test the plan consistent with other national and local planning programs; (2) Ensure the integration of disaster risk reduction and climate change adaptation into local development plans, programs and budgets as a strategy in sustainable development and poverty reduction;***

WHEREAS, Section 21, supra, provides for the Local Disaster Risk Reduction and Management Fund (LDRRMF) which allocation shall not be less than five percent (5%) of the estimated revenue from regular sources. The LDRRMF shall support disaster risk reduction and management activities such as, but not limited to, pre-disaster preparedness programs including training, purchasing life-saving rescue equipment, supplies, and medicines, for post-disaster activities, and for the payment of premiums on calamity insurance;

WHEREAS, pursuant to the Commission on Audit Circular No. 2012-002 (5.1.11), "all unexpended/unobligated balance of the LDRRMF for the Capital Outlay shall be made continuing in the General Fund books until the projects funded therefor are completed, and any savings shall be available for use in the disaster risk reduction and management activities provided in the LDRRMFIP;

WHEREAS, the City Accounting Department certified that there is a total of **Five Hundred Fourteen Million Seven Hundred Ninety Three Thousand Six Hundred Nineteen Pesos and 66/100 (Php514,793,619.66)** unexpended balance in continuing appropriations of the Local Disaster Risk Reduction and Management to be used for the Capital Outlay for disaster prevention and mitigation, disaster preparedness, disaster response, and disaster recovery and rehabilitation;

WHEREAS on **March 30, 2023**, the Muntinlupa LDRRMC adopted **Resolution No. 3 series of 2023** requesting the Sanggunian to approve the utilization of a portion of the LDRRMF continuing appropriation in the amount of **Two Hundred Twenty-Three Million Eighteen Thousand Three Hundred Ninety-Two Pesos (PHP223,018,392.00)** to support the following PPAs in the LDRRMF Investment Plan:
