**WHEREAS**, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that "Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

**WHEREAS**, Article 86(b)(1)(vi), of the Rules and regulations implementing the LGC of 1991, provides that "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, **the City Mayor shall:** (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) **represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;**"

**WHEREAS**, Section 2 of Republic Act 10121, also known as the Philippine Disaster Risk Reduction and Management Act of 2010 declares that it is a policy of the State to adopt a disaster risk and management approach that is holistic, comprehensive, integrated and proactive and to engage the participation of civil society organizations, the private sector and volunteers in risk reduction programs to complement resources and ensure effective delivery of services;

**WHEREAS**, the Philippines belongs to the Pacific Ring of Fire and is vulnerable to typhoons and earthquakes. National and local governments have long been advised to prepare for the "Big One" an earthquake of magnitude emanating from active faults that have not generated any historical surface-rupturing events which can significantly affect the region and surrounding areas in the Philippines;

**WHEREAS**, the City Government of Muntinlupa (CGM), is one of the local government units transected by the west valley fault and is prone to massive destruction to properties and deaths when the Big One occur. Preparations not only in recovery and proper disposal of cadaver is a must as mishandling of dead persons will pose another health hazard when not properly planned;

**WHEREAS**, the CGM sought the aid of the funeral parlors in the City to assist in the collection, preservation, storage and disposal of dead bodies in the aftermath of earthquakes and other disasters as these businesses are equip with the technical knowledge and trainings on the matter;

**WHEREAS**, as part of their civic duties, **King Harold Funeral Parlor**, located at **National Road, Barangay Bayanan, Muntinlupa City** and represented by **Mr. Harold A. Manipol**, will voluntarily and out of benevolence, assist in the collection, preservation, storage and disposal of cadaver as a result of mass fatalities arising from disasters and calamities at no cost to the CGM;

**WHEREAS**, The City Legal Office interposes no objection to the said Memorandum of Agreement, and further recommended that, **"The City may contract directly with the funeral parlors, instead of executing a framework agreement. However, the procurement of the necessary materials and equipment to be provided to the contractors must still undergo the appropriate mode of procurement under Republic Act 9184;"**

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the **10<sup>th</sup> Sangguniang Panlungsod**, to authorize the **Hon. City Mayor Rozzano Rufino B. Biazon** to enter into and sign in behalf of the City Government of Muntinlupa a Memorandum Of Agreement (MOA) with **King Harold Funeral Parlor**, located at **National Road, Barangay Bayanan, Muntinlupa City** represented by its General Manager **Mr. Harold A. Manipol**.

**ADOPTED**, by the **10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa** this **3<sup>rd</sup>** day of **March 2023**, on its **39<sup>th</sup> Regular Session**.
