WHEREAS, Section 25 or Republic Act 7160, also known as the Local Government Code (LGC) of 1991 provides that, *"National agencies and offices with project implementation functions shall coordinate with one another and with the local government units concerned in the discharge of these functions. They shall ensure the participation of local government units both in the planning and implementation of said national projects;"*

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing the LGC of 1991, provides that *"(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";*

WHEREAS, Republic Act 8792 otherwise known as the Electronic Commerce Act, provides that an electronic online network facilitates the open, speedy, and efficient electronic online transmission, conveyance, and use of electronic documents amongst all government departments, agencies, bureaus, offices, up to the division level, and to the regional and provincial offices, government-owned and controlled corporations, local government units, other public instrumentalities, universities, colleges and other schools and universal access to the general public;

WHEREAS, MMDA Resolution No. 23-02, series of 2023 or "The Resolution Approving and Adopting a Single Ticketing System Through the Establishment of the Metro Manila Traffic Code of 2023 which provides for a a System of Interconnectivity among Government Instrumentalities involved in the Transport and Traffic Management In Metro Manila, was adopted by the Sangguniang Panlungsod through the enactment of Ordinance 2023-055, An Ordinance Adopting The Metro Manila Traffic Code Of 2023 And Institutionalizing The Single Ticketing System, Harmonized Fines And Penalties, And Thereby Revising/Modifying The Existing Traffic Code Of The City Of Muntinlupa;

WHEREAS, the enactment of Ordinance 2023-055 paved and set the direction for the CGM to interconnect its apprehension data base and traffic apprehension project with the LTO IT Project on motor vehicle and driver's license database;

WHEREAS, the interconnectivity of the information systems in both parties will contribute efficiency to the payment of fines and penalties as well as create an alarm or alert in the registration of vehicles and on the renewal of driver's license;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **10th Sangguniang Panlungsod of Muntinlupa**, to authorize the **Honorable City Mayor Rozzano Rufino B. Biazon** to represent and sign in behalf of the City Government of Muntinlupa (CGM) a **Data Sharing Agreement (DSA)** with the **Land Transportation Office (LTO)** represented by **Assistant Secretary Atty. Jose M. Tugade**, on the **Interconnectivity of Muntinlupa Traffic Apprehension Database** to **LTO's Information Technology (LTO-IT) Project**.

RESOLVED FURTHER, that collection and processing of data under the DSA shall adhere to the provisions of Republic Act 10173 or the Data Privacy Act especially on the provisions of safeguards in accordance with National Privacy Commission Circular 16-02 on DSA Agreements involving government agencies;

ADOPTED, by the **10th Sangguniang Panlungsod of Muntinlupa** this **11th day of April 2023**, on its **40th Regular Session**.
