BIAZON TO REPRESENT AND SIGN IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA (CGM) THE MEMORANDUM OF AGREEMENT (MOA) AND DATA SHARING AGREEMENT (DSA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT-NATIONAL CAPITAL REGION (DSWD-NCR) REPRESENTED BY ITS OFFICER-IN-CHARGE (OIC) REGIONAL DIRECTOR MICHAEL JOSEPH J. LORICO, FOR THE IMPLEMENTATION OF SUSTAINABLE LIVELIHOOD PROGRAM (SLP)

WHEREAS, Section 25 of Republic Act 7160, also known as the Local Government Code (LGC) of 1991 provides that, ***“National agencies and offices with project implementation functions shall coordinate with one another and with the local government units concerned in the discharge of these functions. They shall ensure the participation of local government units both in the planning and implementation of said national projects;”***

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing the LGC of 1991, provides that ***“(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.”;***

WHEREAS, Section 2 of Republic Act 10173 or the Data Privacy Act, states that, ***It is the policy of the State to protect the fundamental human right of privacy, of communication while ensuring free flow of information to promote innovation and growth. The State recognizes the vital role of information and communications technology in nation-building and its inherent obligation to ensure that personal information in information and communications systems in the government and in the private sector are secured and protected.;***

WHEREAS, Section 22, supra, provides that, "All sensitive personal information maintained by the government, its agencies and instrumentalities shall be secured, as far as practicable, with the use of the most appropriate standard recognized by the information and communications technology industry, and as recommended by the Commission. The head of each government agency or instrumentality shall be responsible for complying with the security requirements mentioned herein while the Commission shall monitor the compliance and may recommend the necessary action in order to satisfy the minimum standards.';

WHEREAS, the DSWD-NCR is mandated to effectively implement programs, projects, and services that will alleviate poverty and empower disadvantaged individuals, families and communities to improve quality of life;

WHEREAS, pursuant to the mandate, the DSWD launched the Sustainable Livelihood Program (SLP) which strive to improve the socio-economic capacity of its program participants through a micro-enterprise development and employment facilitation program that shall ultimately provide a sustainable income source;

WHEREAS, under the SLP, both the CGM and the DSWD can deliver package of services to address poverty, empower citizens, and promote inclusive growth through various livelihood programs, projects and activities;

WHEREAS, the effectivity of the SLP entails the collection, processing, exchanges and storage of data which are vital to the effective cascading of the program, thus, in compliance with the Data Privacy Act, and the National Privacy Commission Circular 16-02 or the Data Sharing Agreement between government agencies, a DSA is a requirement sine-qua-non;

NOW THEREFORE, BE IT RESOLVED, AS IT HEREBY RESOLVED, by the 10th Sangguniang Panlungsod of Muntinlupa, to authorize the **Honorable Mayor Rozzano Rufino B. Biazon** to represent and sign in behalf of the City Government of Muntinlupa (CGM) the **Memorandum of Agreement (MOA)** and **Data Sharing Agreement (DSA)** with the **Department of Social Welfare and Development-National Capital Region (DSWD-NCR)** represented by its **Officer-in-Charge (OIC) Regional Director Michael Joseph J. Lorico**, for the implementation of **Sustainable Livelihood Program (SLP)**

RESOLVED FURTHER, that the parties shall adhere to the provisions in the **MOA/DSA** which are embodied in the **Specific implementation Agreement (SIA)** which will form an integral part of this Resolution.

ADOPTED, by the 10th Sangguniang Panlungsod of Muntinlupa this 17th day of April 2023, on its 41st Regular Session.
