A RESOLUTION AUTHORIZING THE HON. CITY MAYOR ROZZANO RUFINO B. BIAZON, TO ENTER INTO TERMS OF PARTNERSHIP (TOP) WITH THE DEPARTMENT OF HEALTH-METRO MANILA CENTER FOR HEALTH DEVELOPMENT (DOH-MMCHD), REPRESENTED BY ALELI ANNIE GRACE P. SUDIACAL, DIRECTOR IV, ON THE IMPLEMENTATION OF THE ANNUAL OPERATION PLAN (AOP) FOR CALENDAR YEAR 2023, PURSUANT TO THE LOCAL INVESTMENT PLAN FOR HEALTH (LIPH) 2023-2025, IN THE AMOUNT OF FOUR HUNDRED NINETY-NINE MILLION FOUR HUNDRED FIFTY-FOUR THOUSAND FIVE HUNDRED FIFTY-SEVEN PESOS AND 90/100 (PHP499,454,557.90)

WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, "**every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;**

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations implementing the LGC provides that, "**(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.**";

WHEREAS, Republic Act No. 11223 or the Universal Health Care Act, is enacted to ensure that all Filipinos are guaranteed equitable access to quality and affordable health care, goods and services, and protected against financial risk. Pursuant thereto, the DOH and the local government units (LGUs) are mandated to provide a health care delivery system that will afford every Filipino a primary care provider that would act as the navigator, coordinator, and initial and continuing point of contact in the health care delivery system;

WHEREAS, Section 19.5 of the Implementing Rules and Regulations of R.A. 11223 states that, *“the DOH shall provide or facilitate the provision of necessary support and incentives to assist the LGUs in integrating their local health system into province-wide and city-wide health systems that are resilient, sustainable, and responsive to the needs of the population; Provided, that the assistance shall include financial and non-financial matching grants to strengthen health systems management and health service delivery; Provided further, that the DOH shall provide an environment that promotes the exchange of knowledge and good practices among the levels of the health care delivery system.”*;

WHEREAS, the Local Investment Plan for Health (LIPH) is the key instrument in foregoing the DOH and LGU partnership to carry out health reforms and is implemented through the AOP. The AOP is the yearly translation of the LIPH, it details the programs, plans and activities (PPAs) and systems interventions that are to be implemented in the City-wide Health Systems (CWHS) in a particular year;

WHEREAS, the Sangguniang Panlungsod of Muntinlupa, through Resolution 2022-129, adopted the Programs, Projects And Activities (PPAS) in the Annual Investment Plan (AIP) for Fiscal Year 2023. Included in the City Council approved AIP are the PPAs for the Social Development, **Health Sub-Sector** which were submitted for evaluation of the DOH-MMCHD Appraisal Committee;

WHEREAS, for purposes of formalizing the City-Wide Health Services (CWHS) agreement between the DOH Center for Health Development and the City Government of Muntinlupa on the implementation of the AOP for a particular year, a TOP must be entered and executed between parties;

WHEREAS, under the TOP, the implementation of the approved AOP for Calendar Year 2023, shall be funded by various sources which may include the following: 1. LGU funds; 2. Fund transfer from the DOH-CHD; 3. Support in kind or commodities from DOH regular budget of the Central Office and MMCHD; 4. Philhealth payments; and 5. Other funds identified by the DOH- MMCHD and LGU;

WHEREAS, the TOP likewise provides that the City Government of Muntinlupa shall receive an estimated amount of **Four Hundred Ninety-Nine Million Four Hundred Fifty-Four Thousand Five Hundred Fifty-Seven Pesos and 90/100 (Php499,454,557.90)** financial and non-financial grant;

WHEREAS, the City Legal Office has no objection to the provision of the TOP subject to the compliance with the pertinent auditing and accounting rules and regulations particularly on liquidation of funds transferred and accounting of goods or commodities received.
