WHEREAS, the **2022 Philippine Bar Examination**, the second digitalized Bar Exams in the Philippines, chaired by **Supreme Court Justice Alfredo Benjamin Caguioa** was held on November 9, 13, 16, and 20, 2022 in various regional testing venues nationwide;

WHEREAS, the Bar Exams cover the usual subjects including Political and International Law, Criminal Law, Labor Law and Social Legislation, Civil Law, Mercantile Law, Remedial Law, and Legal Ethics;

WHEREAS, on 14 April 2023, the **Supreme Court En Banc** released the official results of the 2022 Bar Examinations with 43.47% passing rate or 3,992 out of 9,183 examinees;

WHEREAS, Councilor **Rachel Katriel Ann Cruz Arciaga** is an incumbent Member of the **10th Sangguniang Panlungsod** representing **District 1** of the **City of Muntinlupa**;

WHEREAS, **Coun. Arciaga**, graduated and completed her **Juris Doctor** in San Beda College-Alabang School of Law, Muntinlupa City, and is among the successful 2022 Bar Examination passers;
