WHEREAS, the **Philippine Bar Examination** is the professional licensure examination for lawyers in the country exclusively administered by the Supreme Court of the Philippines through the Supreme Court Bar Examination Committee;

WHEREAS, the **2022 Philippine Bar Examination**, the second digitalized Bar Exams in the Philippines, chaired by **Supreme Court Justice Alfredo Benjamin Caguioa** was held on November 9, 13, 16, and 20, 2022 in various regional testing venues nationwide;

WHEREAS, the Bar Exams cover the usual subjects including Political and International Law, Criminal Law, Labor Law and Social Legislation, Civil Law, Mercantile Law, Remedial Law, and Legal Ethics;

WHEREAS, on 14 April 2023, the **Supreme Court En Banc** released the official results of the 2022 Bar Examinations with 43.47% passing rate or 3,992 out of 9,183 examinees, including thirty-two (32) Muntinlupeño Bar Passers, to wit:
