DELA ROSA, MD FOR THE FREE BREAST ULTRASOUND AND/OR MAMMOGRAPHY TEST/S OF PATIENTS/BENEFICIARY/IES REFERRED BY KALINGANG MUNTI ACTION CENTER (KMAC) AND VERIFIED BY THE GENDER AND DEVELOPMENT (GAD) OFFICE

WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that "Every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, Article 86(b)(1)(vi), of the Rules and regulations implementing the LGC of 1991, provides that "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, **the City Mayor shall:** (1) exercise the general supervision and control all programs, projects, services, and activities of the City, and in this connection, shall: xxx (vi) **represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance;**"

WHEREAS, Article VI, Section 15 of Ordinance 15-114, otherwise known as An Ordinance Enacting The Gender And Development (GAD) Code of the City of Muntinlupa, provides that **the City Government shall endeavor to provide women access to a full range of comprehensive health services including the prevention and treatment of diseases and sexual and reproductive health services throughout their cycles;**

**WHEREAS**, Section 1 of Ordinance 2021-234, the ordinance which amended Ordinance 15-114, likewise mandated the GAD office to “**provide assistance and strengthen linkages in the identification and mobilization or resources for GAD PPAs;**”

**WHEREAS**, pursuant to the aforementioned mandates, the City Government of Muntinlupa and the MCMI forged a partnership to provide female Muntinlupenos, referred by the Kalingang Munti Action Center (KMAC) and verified by the GAD Office through its prescribed standards and policies, free access to ultrasound and or mammography test/s;

**WHEREAS**, as part of MCMI's social responsibility, a discounted package rate for Mammogram and Breast Ultrasound worth Three Thousand Two Hundred Pesos (Php3,200.00) shall be billed for each referred beneficiary/ries which shall be for the account of City Government.

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the **10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa**, to authorize the Honorable City Mayor Rozzano Rufino B. Biazon to represent the City Government of Muntinlupa to enter and sign the **Memorandum of Agreement (MOA)** with the **Medical Center Muntinlupa, Inc (MCMI)** represented by its President Esmeralda V. Dela Rosa, MD for the **free breast ultrasound and/or mammography test/s** of patients/beneficiary/ies referred by **Kalingang Munti Action Center (KMAC)** and verified by the **Gender and Development (GAD) office**
