**WHEREAS**, on April 24, 2023 the 10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa enacted Ordinance No. 2023-076, entitled, "An Ordinance Adopting Resolution No. 1, Series Of 2023, Of The City Development Council Entitled, "A Resolution Adopting The Consolidated Supplemental Annual Investment Program (AIP) No. 1 and Its Supplemental Budget for FY 2023 and Favorably endorsing the same to the Sangguniang Panlungsod", and approving Supplemental Budget No. 1, in the amount of Four Hundred Eleven Million Nine Hundred Seventy-Five Thousand Five Hundred Ninety-Six Pesos And 90/100 (Php411,975,596.90) covering the various expenditures for the Operation of the City Government and appropriating the necessary funds for the purpose, subject to existing Laws, Rules and Regulations.";




