A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ROZZANO RUFINO B. BIAZON TO REPRESENT THE CITY GOVERNMENT MUNTINLUPA IN A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE BAND OF MERCY (PBM) REPRESENTED BY ITS EXECUTIVE DIRECTOR PERCY G. BENEDICTOS FOR THE TREATMENT AND REHABILITATION OF STRICTLY QUALIFIED INDIGENT PATIENTS WITH DISABILITIES AND DEFORMITIES, SUCH AS CLEFT LIP/PALATE, CLUBFOOT, AND HERNIA

WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, **“every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”**;

WHEREAS, SECTION 35, supra, provides, “Local government units may enter into joint ventures and such other cooperative arrangements with people’s and nongovernmental organizations to engage in the delivery of certain basic services, capability-building and livelihood projects, and to develop local enterprises designed to improve productivity and income, diversify agriculture, spur rural industrialization, promote ecological balance, and enhance the economic and social well-being of the people”;

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing the LGC (LGC-IRR), provides that, "**(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.**"

WHEREAS, the **Philippine Band of Mercy**, a charitable non-government organization with the mission of providing thousands of indigent Filipinos physically disfigured at birth, with opportunity to avail of medical help and support for reconstruction, rehabilitation and medical treatment, requested the City Government of Muntinlupa to participate in the PBM's Cleft Surgery Program

WHEREAS, the Cleft Surgery Program, coursed through the various Offices of the City Government of Muntinlupa such as the City Health, City Social Welfare development and the Persons with Disabilities, not only include cleft lip/palate but also clubfoot and hernia;

WHEREAS, through the execution of a Memorandum of Agreement between CGM and PBM, the deformities and disabilities mentioned herein will be decisively dealt with effective information dissemination, consultation and medical services benefiting a segment of the city's constituency;

WHEREAS, the City Legal Office posed no objection, subject to the suggested "**adding a term of one (1) or two (2) years for the effectivity of the MOA with an annual review of the provisions thereof subject to renewal**";

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **10th Sangguniang Panlungsod of Muntinlupa**, to authorize the **Hon. City Mayor Rozzano Rufino B. Biazon**, to enter into a **Memorandum of Agreement (MOA)** with the **Philippine Band of Mercy (PBM)** represented by its **Executive Director Percy G. Benedictos** on the treatment and rehabilitation of strictly qualified indigent patients with disabilities and deformities, such as cleft lip/palate, clubfoot, and hernia.

ADOPTED, by the **10th Sangguniang Panlungsod of Muntinlupa** this **22ND** day of **May 2023**, on its **46th Regular Session**.




