A RESOLUTION AUTHORIZING THE CITY MAYOR HON. ROZZANO RUFINO B. BIAZON TO REPRESENT THE CITY GOVERNMENT MUNTINLUPA IN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH-METRO MANILA CENTER FOR HEALTH DEVELOPMENT, REPRESENTED BY ALELI ANNIE GRACE P. SUDIACAL, MP, MPH, CESE, DIRECTOR IV, ON THE TRANSFER AND RELEASE OF FOUR MILLION FIVE HUNDRED THOUSAND PESOS (PHP4,500,000.00) **FUNDS** COMING FROM THE HEALTH ENHANCEMENT PROGRAM (HFEP) UNDER R.A. 11639 OR THE GENERAL APPROPRIATION ACT (GAA) OF 2023 FOR THE UPGRADING AND REHABILITATION OF THE TUNASAN HEALTH CENTER AND THE SOUTHVILLE HEALTH CENTER EMERGENCY CARE CLINIC.

WHEREAS, Article XIII Sec 11 of the Philippine Constitution provides, The State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost. There shall be priority for the needs of the underprivileged sick, elderly, disabled, women, and children. The State shall endeavor to provide free medical care to paupers.;

WHEREAS, Item no. 6 under the Special Provisions under R.A. 11639 or the General Appropriation Act (GAA) of 2023 provides for the use of the Health Facilities Enhancement Program (HFEP) for the construction, upgrading, or expansion of government health care facilities and purchase of hospital equipment, and motor vehicles for such facilities, with priorities in the Universal Health Care sites and GIDAs, including the upgrading of facilities for COVID-19 response and equipping and construction of on-going projects;

WHEREAS, Section 16 of Republic Act (R.A.) No. 7160, otherwise known as the Local Government Code of 1991 (LGC), provides that, "every local government unit (LGU) shall exercise powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, Article 86(b)(1)(vi) of the Rules and Regulations Implementing the LGC (LGC-IRR), provides that, "(b) For efficient, effective, and economical governance the purpose of which is the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, the City Mayor shall: (1) Exercise general supervision and control over all programs, projects, services, and activities of the City, and in this connection, shall: Xxx (vi) Represent the City in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinance.";

WHEREAS, pursuant to RA 11639, the Department of Health through the Metro Manila Center for Health Development (DOH-MMCHD) will transfer and release to the City the amount of *Four Million Five Hundred Thousand Pesos (Php4,500,000.00)* for the upgrading, rehabilitation, repair, construction and/or completion of the Tunasan Health Center and the Southville Health Center Emergency Care Clinic;

WHEREAS, the City Legal Office has no objection to the MOA, subject to strict compliance with pertinent accounting and auditing rules and regulations on receipt and liquidation of funds received.

WHEREAS, the City must also ensure compliance with its contractual obligation under the MOA such as the submission of necessary documents and completion of the project within the specified duration, appropriation of funds for the continuing maintenance and operation of the health facilities and acquisition of equipment for the project;

WHEREAS, the DOH through the Health Facilities Enhancement Program (HFEP) for 2023 has appropriated the amount of Four Million Five Hundred Thousand Pesos (Php4,500,000.00) for the upgrading, rehabilitation, repair, construction and/or completion of the health facilities, to be undertaken by the City Government of Muntinlupa
