THIS AGREEMENT made the ____ day of ____ 20__ between **CITY GOVERNMENT OF MUNTINLUPA** of the Philippines (hereinafter called "the Entity") of the one part and **CHARKIEL ENTERPRISES** with address at Muntiniupa City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the **Printing of Business Permit, Certificates, Forms, Permit Card, Sintra Board, Letterhead & Materials for the use of Various Offices** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Nine Hundred Fifty Five Thousand Two Hundred Thirty Two Pesos (P1,955,232.00)**(hereinafter called "the Contract Price").


