MUNTINLUPA with address at City Hall, National Road, Putatan, Muntinlupa City, (hereinafter called the "Entity") and KME DESIGN & CONSTRUCTION with address at Muntinlupa City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute **Construction of New Muntinlupa City Public Market Phase 6 at Brgy. - d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
