**WHEREAS**, Article 99, (1)(i) of Rules and Regulations Implementing the Local Government Code of 1991, states that, "the Sangguniang Panlungsod as the Legislative Body of the city shall enact ordinances, approve resolutions and appropriate fund for the general welfare of the city and its inhabitants pursuant to Section 16 of the Code, xxx, as one of the corporate powers of the city as provided in Rule IX of these rules, and shall: (i) **Review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punongbarangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punongbarangay.**";

**WHEREAS**, the Budget Office, endorsed to the Sangguniang Panlungsod the **2023 Annual Budget of Barangay Putatan** amounting to **One Hundred Fourteen Million Pesos (Php114,000,000.00)**;

**WHEREAS**, the City Budget Office after evaluation of **Barangay Putatan** submitted budget found the same to have complied with rules, regulations, and appropriate memoranda on budget preparation, recommended its adoption;

**WHEREAS**, the proposed expenditure program follows the development directions of the Barangay Development Plan as approved by the Barangay Assembly and is fully consistent with the approved barangay Annual Investment Program (AIP) for the Fiscal Year 2023;

**WHEREAS**, the Barangay Appropriation Ordinance No. 2022-10 01-Series of 2023, dated December 19, 2022 and submitted to the Budget Office on May 18, 2023 is recommended to declare operative in its entirety effective January 1, 2023, **subject to adjustments due to the reduce amount of NTA and posting requirements under R.A 7160.**

**WHEREAS**, the City Budget Office recommended that the **FY 2023 Annual Budget of Barangay Putatan** be **declared operative in the entirety effective January 1, 2023** subject to compliance with the:

- a. **Procurement of goods, supplies and materials, equipment and infrastructure/civil works shall be subject to the pertinent provisions of Republic Act 9184 (Government Procurement Reform Act) and prior clearances from pertinent agencies as maybe needed. In addition, all procurement shall be included to the duly approved Annual Procurement Plan;**
