AN ORDINANCE GRANTING FRANCHISE TO VC LEISURE VENTURE CORPORATION, REPRESENTED BY IVAN ANGELO CUEVAS, DIRECTOR OF BUSINESS DEVELOPMENT TO OPERATE TRADITIONAL AND ELECTRONIC BINGO, EGAMES AND ALL OTHER GAMES APPROVED BY PAGCOR, LOCATED AT SM SUPERCENTER MUNTINLUPA, NATIONAL ROAD, BARANGAY TUNASAN, MUNTINLUPA CITY

WHEREAES, under Section 458(a)(3) of Republic Act No. 7160, states that, "The Sangguniang Panlungsod has the authority to grant franchise by enacting ordinance authorizing the issuance of permits and licenses and levying taxes fees and other charges";

WHEREAS, City Ordinance No. 99-040, regulates the establishment of legalized gambling activities only in recognized malls within the jurisdiction of Muntinlupa City;

WHEREAS, the VC Leisure Venture Corporation, is a Corporation duly organized and existing under and by virtue of the laws of the Philippines with principal office at 6<sup>th</sup> Floor Kingstone Excell Building, Civic Drive, Barangay Alabang, Muntinlupa City;

WHEREAS, VC Leisure Venture Corporation applied for a franchise, to operate Electronic Bingo/Gaming and all other games approved by PAGCOR located at SM Supercenter Muntinlupa located at National Road, Barangay Tunasan, Muntinlupa City.;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the 10<sup>th</sup> Sangguniang Panlungsod in Session Assembled that:

SECTION 1. VC Leisure Venture Corporation, is hereby granted authority to operate Electronic Bingo/Gaming located at SM Supercenter Muntinlupa located at National Road, Barangay Tunasan, Muntinlupa City..

**SECTION 2. VC Leisure Venture Corporation**, shall be issued Mayor's Permit for the operation of the Electronic Bingo/Gaming.

**SECTION 3.** The authority to operate Electronic Bingo/Gaming granted herein shall be limited as follows:

- 1) *The holding of e-Bingo/e-Games shall be in accordance with the Rules and Regulation as promulgated by the Philippine Amusement and Gaming Corporation (PAGGOR).*
- 2) *The holding of e-Bingo/e-Games shall be in accordance with Ordinance No. 02-032, otherwise known as an, Ordinance prohibiting minors inside Bingo Halls in all shopping malls in the City of Muntinlupa.*
- 3) *Bingo Games Participants/players shall likewise adhere to the provisions of Ordinance 17-072 as amended on the anti-smoking Ordinance of the City.*

**SECTION 4.** Upon approval of this ordinance **VC Leisure Venture Corporation**, shall remit to the **City Treasurer** the amount prescribed under existing **Franchise Tax** of the City which is payable yearly/annually at the rate of **fifty percent (50%) of one percent (1%)** of the **Gross Annual Receipts** pursuant to Section 137 of Republic Act No. 7160.

**SECTION 5.** The grant of authority to operate bingo games herein abovementioned shall be for a period of **five (5) years** from the date of approval of this ordinance.

**SECTION 6.** This authority to operate Electronic Bingo/Gaming is given upon the representation of the **VC Leisure Venture Corporation**, that the same is a requirement in its **application for a permit and license to operate** Electronic Bingo/Gaming in the **Philippine Amusement and Gaming Corporation (PAGCOR)**. Should the **PAGCOR** not give license or permit to operate Bingo to **VC Leisure Venture Corporation**, this ordinance shall be considered **without force and effect**.

**SECTION 7. Separability Clause** – should any provision, section, or part of this ordinance be adjudged or declare illegal or unconstitutional by any court of competent jurisdiction, such judgment shall not affect or impair the remaining provision, sections, or part which shall continue to be in full force and effect.

**SECTION 8. Repealing Clause** – All ordinance or any provision of ordinances which are inconsistent with this ordinance are hereby repealed.

**SECTION 9. Effectivity** - This ordinance shall take effect upon its approval.

**ENACTED**, by **10<sup>th</sup> Sangguniang Panlungsod of Muntinlupa** this **13<sup>th</sup>** day of **June 2023**, on its **49<sup>th</sup>** Regular Session.
