- a. Posting requirements under DBM-DILG-NYC JMC No. 1 Series of 2019;
- b. Appropriations to be disbursed in accordance with Art 425 of the IRR, of Republic Act 7160 (Local Government Code); RA 10742 (Sanggunian Kabataan Reform Act of 2015) and its IRR; DBM-DILG JMC No. 1 s. 2019;
- c. Compliance to the implementing guidelines and procedure pursuant to Section 4, of RA 11768 (amendments to RA 10742) and DBM Local Budget Circular No. 148 dated December 23, 2022;
- d. Procurement of goods, supplies and materials, equipment and infrastructure/civil works shall be subject to the pertinent provisions of Republic Act 9184 (Government Procurement Reform Act) and prior clearances from pertinent agencies as maybe needed. In addition, all procurement shall be included to the duly approved Annual Procurement Plan;

WHEREAS, the SK Barangay Buli FY 2023 Budget was found to have substantially complied with the laws and the same was executed pursuant to the prescribed power of the barangay;

NOW THEREFORE, BE IT ENACTED, by the 10th Sangguniang Panlungsod of Muntinlupa, to approved the 2023 Annual Budget of Sangguniang Kabataan (SK) Budget of Barangay Tunasan, amounting to Three Million One Hundred Forty-Two Thousand Thwenty-Nine Pesos.
