WHEREAS, Section 23 of Republic Act No. 10742, also known as Sangguniang Kabataan Reform Act of 2015, mandates the creation of **Local Youth Development Council (LYDC)** in every city, municipality and province;

WHEREAS, the creation of the **LYDC** will be the enabling mechanism for meaningful youth participation through the mutual coordination of the Local Development Council (LYDC) and the Sangguniang Kabataan in the City of Muntinlupa;

WHEREAS, Section 21(c) of Republic Act 11768 otherwise known as An Act Strengthening The Sangguniang Kabataan, Institutionalizing Additional Reforms To Revitalize Youth Participation In Local Governance And By Providing Honorarium, Other Benefits, And Privileges, Amending For The Purpose Certain Sections Of Republic Act No. 10742, Otherwise Known As The "Sangguniang Kabataan Reform Act Of 2015" provides that the **Pederasyon ng Sangguniang Kabataan** shall convene the LYDC **every three (3) months** to conduct consultations with youth organizations ;

WHEREAS, Section 27, supra, states that, "**The local government unit may appropriate not less than one (1 %) percent of its annual budget for the Local Youth Development Office, which shall be used for the implementation of the Local Youth Development Plan (LYDP), convening the meetings of the concerned Pederasyon ng mga Sangguniang Kabataan and LYDC, as well as its operations and effective functioning**";

WHEREAS, on August 6, 2018, the Sangguniang Panlungsod ng Muntinlupa enacted Ordinance 18-184 also known as the Creation of the Local Youth development Council of the City of Muntinlupa;

WHEREAS, the enactment of RA 11768 in 2022 introduced new provisions which are needed to be incorporated in the existing local LYDC of the City of Muntinlupa;

NOW THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the **10th Sangguniang Panlungsod of Muntinlupa**, in Session assembled that:

SECTION 1. Title - this ordinance shall be known as, "**Amendments to Ordinance 18-184 also known as the Local Youth Development Council of the City of Muntinlupa**;

SECTION 2. Section 4 of Ordinance 18-184 otherwise known as the Ordinance Creating the Local Youth Development Council of the City of Muntinlupa, defining its objectives, functions, compositions and appropriate funds therefor and for other purposes is hereby amended to read as follows:

"SECTION 4. Local Youth Development Council - There shall be created Local Youth Development Council in the City of Muntinlupa which shall be responsible for the formulation of policies and implementation of youth development programs, and activities organizations in coordination with various government and non-government organizations."

SECTION 3. Section 7 **Letters d, i and j** of Ordinance 18-184 shall be omitted;

SECTION 4. A new provision shall be inserted as follows:

"Section 10. Honoraria/Allowances - An quarterly allowance/honoraria in the amount of Two Thousand Pesos (Php2,000.00) shall be received by the LYDC members provided in Section 6 of this ordinance, comprised of the SK Federation president and SK Federation Vice President and 19 Council members. The LYDO shall issue an official list of names of such members. The same benefit shall also be received by the LYDO Secretariat. The payment of honoraria/ allowance herein stated shall be on a "subject to availability of fund basis" as well as presence/attendance in the scheduled quarterly meeting/s;

SECTION 5. Appropriations - The City Government of Muntinlupa shall incorporate in its annual budget such amount as may be necessary for the operation and effective functioning of the LYDC;

SECTION 6. Implementing Agency. The Youth Affairs and Sports Development Office (YASDO) is mandated to manage, supervise and monitor the Local Youth Development Council.

SECTION 7. Separability Clause - If, for any reason or reasons, any part or provisions of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.


SECTION 8. Repealing Clause. All previous ordinances inconsistent with this ordinance shall be deemed repealed or modified accordingly.

SECTION 9. Effectivity Clause - This ordinance shall take effect on **Fiscal Year 2014**.




